The overarching goal of the Centre is to promote the understanding and implementation of Sustainable Development, as the only non-self-destructive path of socioeconomic development. Central to ICRE8's mission is the pursuit of excellence in conducting and presenting research and a commitment to explore relevant environmental, natural resources and energy issues, for a variety of circumstances and stakeholders and across different temporal and spatial scales.

The Centre's research expertise includes financial analysis, socio-economic and econometric analysis, environmental valuation, political and institutional analysis, integrated environmental-economic modeling, cost-benefits analysis, multi-criteria analysis, life cycle analysis, risk analysis, geographical information systems, multi-stakeholder mediation techniques, game theory, information technologies and decision making tools development.

The Founder and Scientific Director of ICRE8, Phoebe Koundouri is Professor in Economic Theory and Econometrics, at the Athens University of Economics and Business, School of Economics, and the London School of Economics, Grantham Institute. She is Vice President of the European Association of Environmental and Resource Economists. ICRE8 is strategically managed by a Board of internationally renowned academics and experienced executives, from all over the world, has a core team of 15 Athens-based researchers, and is supported by an interdisciplinary network of more than 60 established researchers from Europe, the US, Asia and Australia. ICRE8's network is also supported by explicit collaborations with a number of world leading institutions in the field of Environmental, Natural Resources and Energy Economics.



organization (without a legal entity) into a more efficient and productive instrument of research, combining state-of-the art academic knowledge with modern organizational principles and structures.

Over the last 18 years ReSEES has produced a large number of research projects and publications with scientific, policy and social impact, which was carried out by an interdisciplinary and international research team led by Prof. Phoebe Koundouri. Since 1997, ReSEES has attracted a total research funding of 20 million Euros. It has collaborated with approximately 150 Universities and Research Institutions and 500 researchers. It has published approximately 250 peer-reviewed research papers and books. The geographical distribution of research funding and research implementation has been mainly Europe and the US, but also a significant number in Latin America, Africa, Asia and Australia.
